Subject: Notation Item 916

Attached for your review and vote is Notation Item 916. This item provides for the addition to the CSB Investigation Protocol, Board Order 040, of a new procedure on employee participation in investigations.

Cefectour

Under the CSB's statute, 42 U.S.C. § 7412(r)(6)(L), employees of facilities where an incident has occurred, and their representatives, have a right to participate in the CSB inspection of the facility that is the same as their right to participate in an inspection under the Occupational Safety and Health Act, 29 U.S.C. § $651 \ et \ seq$. The new investigation protocol section proposed by this item would provide guidance to CSB personnel on involvement by facility employees and their representatives in CSB investigations. Like the rest of the protocol, this procedure is intended only for internal direction to CSB staff. However, I expect that, if this procedure is approved by the Board, the CSB will publish a separate informational document on employee/representative participation in its investigations.

Whereas,

- 1. Board Order 040 (adopted by Notation Item 425 on March 31, 2006; amended by Notation Item 894 on December 7, 2011) establishes the investigation protocol for the CSB;
- 2. The CSB's enabling statute, 42 U.S.C. § 7412(r)(6)(L), provides that facility employees and their representatives have a right to participate in CSB inspections of the facility to the same extent as they have a right to participate in inspections under the Occupational Safety and Health Act, 29 U.S.C. § 651 *et seq.*; and
- 3. The attachment to this item sets out a proposed new section (Procedure H) of the investigation protocol for the purpose of providing guidance to CSB personnel on participation by facility employees and their representatives in CSB investigations.

Therefore, the Board, pursuant to its authority under 42 U.S.C. § 7412(r)(6)(N), hereby votes to amend Board Order 040, *Investigation Protocol*, by incorporating the new Procedure H, "Employee Participation in Investigations," as shown in the attachment to this item.
