II. MAKING A FOIA REQUEST

2. Brief description of why some requests are not granted and overview of certain general categories of CSB records to which the FOIA exemptions apply.

Why some requests are not granted:

- The requested records are exempt from disclosure pursuant to one of the nine exemptions under the FOIA.
- The requested records do not exist or are not yet in existence.
- The requested records were properly disposed of prior to the date of the request.
- The request would require the agency to compile or create records solely for the purpose of satisfying that request.
- The requester failed to comply with administrative requirements, e.g., reasonable description of records, agreement to pay fees.

Overview of certain general categories of CSB records to which FOIA exemptions apply:

- Records submitted to the CSB by the subjects of agency investigations that contain trade secrets and/or confidential commercial or financial information Exemption 4.
- Records of communications between CSB personnel, or between CSB personnel and the personnel of other federal agencies, that are protected by a legal privilege, e.g., deliberative process privilege, attorney-client privilege Exemption 5.
- Records containing private personal information about individuals, including Personally Identifiable Information Exemption 6.

III. ACRONYMS, DEFINITIONS, AND EXEMPTIONS

1. Agency-specific acronyms or terms used in this Report:

CSB – the Chemical Safety and Hazard Investigation Board.

- 2. Definitions of terms used in this Report:
 - a. Administrative Appeal a request to a federal agency asking that it review at a higher administrative level a FOIA determination made by the agency at the initial request level.
 - b. **Average Number** the number obtained by dividing the sum of a group of numbers by the quantity of numbers in the group. For example, of 3, 7, and 14, the average number is 8.
 - c. **Backlog** the number of requests or administrative appeals that are pending at an agency at the end of the fiscal year that are beyond the statutory time period for a response.

- d. Component for agencies that process requests on a decentralized basis, a "component" is an entity, also sometimes referred to as an Office, Division, Bureau, Center, or Directorate, within the agency that processes FOIA requests. The FOIA now requires that agencies include in their Annual FOIA Report data for both the agency overall and for each principal component of the agency.
- e. **Consultation** the procedure whereby the agency responding to a FOIA request first forwards a record to another agency for its review because that other agency has an interest in the document. Once the agency in receipt of the consultation finishes its review of the record, it responds back to the agency that forwarded it. That agency, in turn, will then respond to the FOIA requester.
- f. **Exemption 3 Statute** a federal statute that exempts information from disclosure and which the agency relies on to withhold information under subsection (b)(3) of the FOIA.
- g. FOIA Request a FOIA request is generally a request to a federal agency for access to records concerning another person (i.e., a "third-party" request), or concerning an organization, or a particular topic of interest. FOIA requests also include requests made by requesters seeking records concerning themselves (i.e., "first-party" requests) when those requesters are not subject to the Privacy Act, such as non-U.S. citizens. Moreover, because all first-party requesters should be afforded the benefit of both the access provisions of the FOIA as well as those of the Privacy Act, FOIA requests also include any first-party requests where an agency determines that it must search beyond its Privacy Act "systems of records" or where a Privacy Act exemption applies, and the agency looks to FOIA to afford the greatest possible access. All requests which require the agency to utilize the FOIA in responding to the requester are included in this Report.

Additionally, a FOIA request includes records referred to the agency for processing and direct response to the requester. It does not, however, include records for which the agency has received a consultation from another agency. (Consultations are reported separately in Section XII of this Report.)

- h. **Full Grant** an agency decision to disclose all records in full in response to a FOIA request.
- i. **Full Denial** an agency decision not to release any records in response to a FOIA request because the records are exempt in their entireties under one or more of the FOIA exemptions, or because of a procedural reason, such as when no records could be located.
- j. **Median Number** the middle, not average, number. For example, of 3, 7, and 14, the median number is 7.
- k. **Multi-Track Processing** a system in which simple requests requiring relatively minimal review are placed in one processing track and more voluminous and complex requests are placed in one or more other tracks. Requests granted expedited processing are placed in yet another track. Requests in each track are processed on a first in/first out basis.

- i. **Expedited Processing** an agency will process a FOIA request on an expedited basis when a requester satisfies the requirements for expedited processing as set forth in the statute and in agency regulations.
- ii. **Simple Request** a FOIA request that an agency using multi-track processing places in its fastest (non-expedited) track based on the low volume and/or simplicity of the records requested.
- iii. **Complex Request** a FOIA request that an agency using multi-track processing places in a slower track based on the high volume and/or complexity of the records requested.
- 1. **Partial Grant/Partial Denial** in response to a FOIA request, an agency decision to disclose portions of the records and to withhold other portions that are exempt under the FOIA, or to otherwise deny a portion of the request for a procedural reason.
- m. **Pending Request or Pending Administrative Appeal** a request or administrative appeal for which an agency has not taken final action in all respects.
- n. **Perfected Request** a request for records which reasonably describes such records and is made in accordance with published rules stating the time, place, fees (if any) and procedures to be followed.
- o. **Processed Request or Processed Administrative Appeal** a request or administrative appeal for which an agency has taken final action in all respects.
- p. **Range in Number of Days** the lowest and highest number of days to process requests or administrative appeals.
- q. **Time Limits** the time period in the statute for an agency to respond to a FOIA request (ordinarily twenty working days from receipt of a perfected FOIA request).
- 3. Concise descriptions of the nine FOIA exemptions:
 - a. **Exemption 1:** classified national defense and foreign relations information.
 - b. **Exemption 2:** internal agency rules and practices.
 - c. **Exemption 3:** information that is prohibited from disclosure by another federal law.
 - d. Exemption 4: trade secrets and other confidential business information.
 - e. **Exemption 5:** inter-agency or intra-agency communications that are protected by legal privileges.
 - f. **Exemption 6:** information involving matters of personal privacy.
 - g. Exemption 7: records or information compiled for law enforcement purposes, to the extent that the production of those records (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could reasonably be expected to

constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions, or (F) could reasonably be expected to endanger the life or physical safety of any individual.

- h. **Exemption 8:** information relating to the supervision of financial institutions.
- i. Exemption 9: geological information on wells.

A. Backlogs of FOIA Requests and Administrative Appeals

Discussion/explanation of backlog:

The number of requests pending in the backlog as of the end of Fiscal Year (FY) 2008 is down almost 30% from the number pending in the backlog at the end of FY 2007. This is an indicator that the CSB's backlog reduction strategies, as established in the agency's FOIA Improvement Plan, are yielding results. Another indicator is the CSB's steady progress on further reduction of the backlog during the first quarter of FY 2009. This can be seen in the current status of the ten oldest pending requests, which were reported above in table VII. E. as of September 30, 2008. Since that date, four of those ten requests have been closed, including the oldest pending request. The CSB has a work plan for completing processing of the second oldest request, which should be closed by February 20, 2009. Closing these two oldest requests has been especially challenging, as each involved thousands of records and one required multiple rounds of submitter notice to address trade secret/confidential commercial information issues. Nevertheless, in both cases, the CSB made substantial partial releases of records to the requesters much earlier in the course of processing them. The CSB anticipates that the remaining six listed oldest pending requests will be closed during FY 2009.

Looking at the end-of-FY2008 backlog overall, of the 25 requests listed above, only 18 remain open as of the date of this Report. In eight of those 18 cases – nearly half – the CSB has made significant partial releases of records to the requesters.

To sustain and, if possible, accelerate backlog reduction over the longer term, the CSB continues to evaluate and implement processing improvements. Such improvements include targeted measures – for example, additional training for FOIA personnel and the use of specific IT solutions – as well as systemic approaches that seek to make information disclosure considerations an integral component of the agency's broader information management practices. The CSB expects these improvements to result in reduced processing times for complex requests, which in turn should yield fewer backlogged requests and a backlog that is less old overall.
